1.0 INTRODUCTION TO THE 2016 REPORT

This document should be viewed as a continuation of the 2012 and 2014 reports of similar title and purpose. However, whereas the 2012 report outlined the historic preservation laws and the Department of Natural Resources and Conservation's (DNRC) procedures developed to comply with these statutory requirements, the 2014 and 2016 reports focus on the cumulative number of DNRC administered Heritage Properties inspected since 2011. The 2016 report updates the total number of cultural and paleontologic resources formally recorded to date on DNRC administered state land. The reader is referred to DNRC's 2012 report if additional background or context is required.

2.0 CULTURAL AND PALEONTOLOGIC RESOURCES ADMINISTERED BY DNRC

Of approximately 5.2 million acres of state land administered by the DNRC, only 274,861 acres (5%) have been inventoried to date for cultural or paleontologic resources. Approximately 32,375 acres were inventoried from 2012 through 2015. Of that total, DNRC staff inventoried approximately 24,610 acres. The remainder (24%) was inspected by consulting cultural resource professionals primarily hired by utilities or oil and gas development companies.

Considering, however, that only 5% of DNRC administered land has been inventoried, 3,036 cultural resources and 79 paleontologic resource locales have been formally recorded. That is an increase of 200 cultural resources and 33 paleontologic resources since the 2012 report was prepared for the Historic Preservation Review Board. Two hundred thirty-five cultural resources on (or partially on) DNRC administered land have been evaluated and determined to meet the criteria of a Heritage Property (Tables 1 and 2). Two of those are National Historic Landmarks, and 25 are listed in the National Register of Historic Places.

Sixty-three presently documented "Heritage Properties" are privately owned even though they are situated on state land (Table 1). These consist of 26 water diversion/distribution systems, one historic schoolhouse, one historic road, one historic Missouri River ferry, and four operational railroads with 32 distinct site numbers. Similarly, approximately 30 additional Heritage Properties are at least partly owned, leased, or managed by another county, state, or federal agency. In these instances, the DNRC may have no legal jurisdiction. At present, it can be concluded that DNRC has some level of administrative authority over at least 142 Heritage Properties (Table 1).

By way of comparison, 2,936 formally recorded cultural resources have not been evaluated, so it is unknown whether or not they meet the criteria of a Heritage Property. Of these unevaluated cultural resources, 2,295 are archaeological properties presumed to be associated with past Native American occupants of the region. They consist of 25 surface or bedrock (tool stone) quarries, 32 animal kill sites, eight probable or definite human burials; 35 probable campsites with buried components and/or hearth features; 1,415 sites that contain tipi ring size stone circles, individual cairns, alignments of cairns, or a combination of these three kinds of surface stone features; one conical timbered lodge; one cribbed log structure; 21 petroglyph sites; 7 pictograph sites; two fortification sites; 718 lithic scatters; five Medicine Wheels/ceremonial structures; nine rock shelters or caves; four prehistoric trails; one possible vision quest structure; 10 scarred/peeled trees; and one pit that may be associated with eagle trapping or defensive purposes. Additionally, 641 are historic in age (post A.D. 1805) and reflect Euro-American settlement and development of the region. They consist of 207 sites associated with historic agriculture/stock raising/homesteading/settlement; one historic cairn/boundary marker; one historic campsite; one historic CCC camp; 44 log cabins/log structures; two historic fences; one historic energy/industrial development site; 12 historic schools (or former school localities); seven historic buildings; six sites associated with historic coal mines; 13 historic hard rock mines/districts; 25 placer mines; two historic quarries; one historic post office; 22 sites associated with historic timber harvesting; 45 historic trash dumps/debris scatters; 59 vehicular, railroad, or foot bridges; 150 historic irrigation systems; 7 historic petroglyph sites; five are historic state roads/stations; and 19 historic roadways or railroad segments.

3.0 HERITAGE PROPERTY IDENTIFICATION AND MANAGEMENT EFFORTS

Because of the large number of Heritage Properties on DNRC administered state land, and the limited resources available to visit each property, the DNRC proposed in 2012 to inspect and report on all of its Heritage Properties over a 10 year period. Of course, newly evaluated Heritage Properties will be added to the inventory list over time, so the quantity of Heritage Properties on DNRC administered land will continue to increase.

To date, 140 Heritage Properties were inspected by the DNRC (Table 3), current conditions of these Heritage Properties were assessed, and Heritage Property forms were completed and submitted to the State Historic preservation Officer.

Of the 140 Heritage Property forms completed by DNRC, 45 are for prehistoric archaeological sites; 29 are for abandoned railroads/abandoned segments of railroad; three are for historic school sites; three are for stage coach roads/stations; 34 are for irrigation/water conservation/water distribution systems, three are for individual mines or mining districts; five are for abandoned segments of historic roadways; three are for homesteads; one is for a historic military site; six are for DNRC or other administrative buildings; and two are historic trails. Heritage Property Forms were also completed for the abandoned portions of the Havre-Rainbow Transmission line where it crosses state land, and a series of historic buildings on DNRC administered land that are associated with the Galen State Hospital (Table 3). Figures 1-5 provide visual representations of the current condition of Heritage Properties on DNRC administered state land with a #1-4 priority rank.

Only two of the 140 Heritage Properties inspected to date (Table 4) are ranked as a top priority (#1 in rank) for preservation efforts. These consist of the DNRC's Anaconda Unit buildings (24DL0206), and the DNRC's Stillwater Unit buildings (24FH0162). The original historic buildings ate the DNRC's Anaconda and Stillwater Units are in perpetual need of maintenance in order to preserve their historic qualities. A total of \$250,600 has been spent toward such preservation and maintenance efforts. The DNRC's management should beginning planning for short-term and long-term up-keep of the historic structures at these two facilities, and begin adding these maintenance costs into legislative budget requests.

Two properties are given a #3 in rank because of either ongoing disturbances or the likelihood of destruction. Archaeological site 24BH1591 consists of a lithic scatter within the proposed expansion boundaries of the Spring Creek Coal Mine. It is given a # 3 in rank just to alert DNRC management to the need for adequate mitigation before it is destroyed with Mine operations. The second site is (24PE0231) the Powder River Supply Depot. Because it is

intermittently subjected to uncontrolled artifact collecting by the general public, more effort should be made to periodically monitor the site and deter ongoing digging and collecting.

Finally, site 24LA0265 is the original Guard Station at the Swan State Forest Headquarters. This site the only original structure remaining that retains its integrity. It is periodically maintained and retains its original historic look and materials. It is currently in no need of maintenance work, but will be in the near future. For this reason it is given a #4 in priority rank. As with the Anaconda and Stillwater Unit buildings, the DNRC's management is encouraged to begin planning for long-term up-keep, and add these expected costs into legislative budget requests.

Excluding staff salaries and travel costs, to date, DNRC has invested approximately \$260,600 to preserve the historic qualities or archaeological data contained in these six priority ranked Heritage Properties (Table 4). An additional \$574,330 is needed to address immediate upgrades, maintenance needs, or developments proposed in the *Montana State-Owned Heritage Property Reporting Forms* for those resources that are in need of attention. If a Heritage Property is in a reasonably stable environment, then no additional action is presently recommended (Table 3).
